THIS DECLARATION, made this 1st day of October, 1994, by TALAMORE PARTNERS LIMITED PARTNERSHIP, a Pennsylvania Limited Partnership (hereafter "Declarant").

WITNESSETH:

WHEREAS, Declarant is the owner of over seventy-five percent (75%) of the lots in the Talamore development and desires to modify the Restrictive Covenants as follows.

NOW, THEREFORE, Declarant, pursuant to the power of the Declarant as owner of over 75% of the lots in the development given in Article XVII C., hereby amends the Declaration of Restrictive Covenants filed in Book 912, Page 57 of the Moore County, North Carolina, Registry, as follows:

- 1. All lots in Phase 1 of Talamore Development shall have a minimum residence size of 1,800 square feet. This square footage measurement shall reflect the heated square footage excepting garages, porches, overhangs and outbuildings.
- 2. This modification is in lieu of the minimum square footage to be shown on the filed plat.
- 3. All other provisions of the Declaration filed in Book 912, Page 57 remain in full force and effect.
